Contract for Participation in the Denver Coliseum Show

1. **Title:** "The Denver Coliseum Show"

2. **Organization:** Eons Expos RLLLP, 38 Fox Ridge Road, Sparta, NJ 07871 henceforth the "Organizer". Email: EonsUncovered@yahoo.com

3. **Location, Dates, Hours:** Denver Coliseum, 1900 44th Street, Denver, CO 80126. Wednesday, 12-Sept through Sunday, 16-Sept 2012. 9 am to 6 pm daily, Sunday 9 am to 4 pm. Vendor access is between 8:30am and 6:30 pm.

THE JUMP-START OPTION IS AVAILABLE FOR TENT DEALERS ONLY

Begin selling on Saturday, Sept. 8th. The additional cost for this option is \$300 which gets you four additional selling days. Set up is on Friday, Sept 7th.

4. **Application for Participation:** Application is made by completing this contract and mailing it together with a 50% deposit to Eons Expos RLLLP, 38 Fox Ridge Road, Sparta, NJ 07871. No application will be accepted without the required deposit. The Vendor herewith agrees to accept all rules, regulations, terms and conditions of the show as being valid for himself / herself and employees. The Vendor accepts full responsibility, and is liable for any and all actions of any employees, or any persons sharing or subletting Vendor's assigned selling space.

5. **Conditions of Application:** The hire of exhibition space is for the entire duration of the show. Vendors may form groups (max two per stand, four per tent) and exhibit their items together. Upon application acceptance, the Organizer herein grants revocable license to use the exhibition booth assigned, subject to these terms and conditions. The Organizer makes no representations or warranties except as expressly set forth herein. The license granted is revocable by Organizer in the event Vendor shall violate this agreement.

6. **Table Assignment:** Where feasible the Organizer will assign the location requested by the Vendor. However, the Organizer reserves the right to change original space assignments if deemed to be in the best interest of the show or for circumstances beyond the control of the Organizer.

7. **Admission Requirements:** The Organizer reserves the right to determine Vendor eligibility for inclusion in the show as well as accept admission of the vendor's items for exhibition. The deposit submitted with application will be refunded if application is declined. Applicants cannot legally claim the right to participate in the show and applications may be turned down by the Organizer without providing a reason. Admission granted can be withdrawn if the necessary prerequisites can no longer be fulfilled and all deposits will be returned.

8. **Contract of Hire:** The contract of hire between the contractual partners (the Vendor and Organizer) becomes valid as soon as the application has been accepted. Organizer shall have full power to interpret the rules, terms and conditions of this contract to make such ruling as may be deemed by the Organizer to be in the best interest of the show. Any written amendments of the foregoing rules, terms and conditions shall bind the Vendor. During the show, due to its temporary nature on facilities which are not regularly operated by the Organizer, various unknown and anticipated contingencies may arise, and the Organizer reserves the right to interpret the relative rights of the parties in the light of such unanticipated circumstances and/or contingencies.

9. **Conditions of Payment:** A 50% deposit shall be paid with application and the balance must be paid by July 15, 2012. **A late fee of \$25 will be assessed EACH WEEK to any Exhibitor failing to pay any part of his/her balance when it is due.** All fees must be paid in full before the start of the show. All returned checks are subject to a \$35 service charge. No foreign checks.

10. **Vendor Cancellation:** The Organizer understands that unforeseen circumstances can arise that will prevent a vendor from attending the show as originally planned. Therefore, release from contract is possible by written request, but is subject to the following refund schedule:

120+ days before show:	Full refund
60-120 days before show:	100% refund of amount paid less \$100 penalty
30-60 days before show:	50% refund of amount paid
<30 days before show:	No refund

11. **Pricing Requirements:** All items for sale must be marked with the price or have signing indicating the price. **THIS IS MANDATORY.**

12. **Refund Policy:** Vendor agrees to accept merchandise purchased at this show to be returned at this show with the stipulation that item(s) are not damaged and in original condition.

13. **Site Conditions:** If the allocated stand/booth has not been claimed one hour after Show opening, the space will be considered

No refund will be made. It is the Vendor's responsibility to keep selling site clean, neat and orderly before, during, and after the show. **THE VENDOR MUST PROVIDE THEIR OWN TABLECLOTHS TO COVER THE TABLE AND REACH DOWN TO THE FLOOR IN FRONT OF THE TABLE. TABLES ARE 30 INCHES (75 CM) WIDE x 30 INCHES HIGH x EITHER 6 OR 8 FEET LONG.**

14. **Set-up** for dealers inside the Coliseum is Tuesday, 11-Sept between 9 am and 6 pm. Special arrangements can be made for larger dealers to set up on Monday. However, due to the high cost and few dealers present, no security (other than the alarm system) is provided on Monday night inside the building. Both the Concourse Level and Arena Level of the Coliseum have a loading dock and roll-up doors. Flatbeds, trolleys, hand-trucks, pallet jacks, etc. must be provided by the vendor. Security will be provided inside the building during set-up beginning Tuesday, 11-Sept at 9 am. Denver police presence begins the morning of the show on Wed, 12-Sept at 8:30 am. Police will remain onsite 24 hours a day until Sunday 16-Sept at 8 PM.

For tent vendors, the two set-up days are as follows:

JUMP-START vendors may set-up on Friday, 7-Sept from 9 am until 8 pm.

Tent vendors not doing JUMP-START will set up Tuesday, 11-Sept from 9 am until 8 pm.

15. **Pack-Up:** pack-up is between 4 pm – 10 pm on Sunday, 16-Sept and can resume on Monday, 17-Sept from 9 am to 5 pm. Clearance of, and departure from the exhibition stands/booth is prohibited before the close of the show so as to maintain visual appeal and security of stand/booth. **DUE TO THE HIGH COST AND FEW DEALERS REMAINING, NO SECURITY IS PROVIDED SUNDAY NIGHT, 16-SEPT.**

16. **Clean up:** Vendor must securely bag or box all trash in his/her selling space prior to departure from show facility. Vendor shall be subject to financial liability for the repair, or replacement of any damages or equipment losses caused by Vendor and/or any labor involved in clean-up or uncontained trash.

17. **Safeguarding, Security Measures:** The Organizer will ensure for the overall security of the exhibition hall by providing both armed and unarmed security, but is exempt of any liability for any loss or damage incurred. Vendors must ensure that both the exhibition stands/booths and items exhibited are properly safeguarded during exhibition hours, during set-up / break-down, and overnight. The Vendor agrees to hold the Organizer blameless in the event of loss or theft of Vendor's merchandise at any time, in any manner, whether through negligence or otherwise.

18. **Parking:** Free parking during will be provided to Vendor and customers alike. Overnight Vendor parking is allowed in designated area.

19. **Sales Tax:** Vendors must file both Colorado State and City of Denver sales tax within 30 days after the event. Vendor agrees to cooperate fully with revenue and taxation authorities and agrees to pay any fine incurred by the Organizer if that fine is a result of Vendor's failure to follow Colorado and/or Denver tax laws.

20. **Insurance:** Vendor is responsible for any and all insurance risks implicit or explicit in Vendor's participation in the Show, including, but not limited to, claims arising from the use of vehicles or equipment, set-up / break-down operations, and from any claim arising from any act or omission of Organizer, its owners, employees, agents, or guests, and from any claims arising from loss, robbery, burglary, pilferage, vandalism, fire, water damage accident, negligence or other cause, regardless of how act or omission generates such claim or claims.

21. **Cancellation / Postponement of the Show:** If, due to circumstances beyond the Organizer's control or in the case of force majeure (e.g. fire, blizzard, etc.), it becomes necessary to close down or postpone the date of the show; this will not entitle Vendors to a release from contract or to a reduction in hiring fees. Vendor shall hold Organizer harmless against all other claims and liabilities to vendor whether arising from expenses incurred, to be incurred, loss of anticipated profit or otherwise.

22. **Liability:** Vendor is liable for all damage caused by themselves, their employees, their representatives, or through their exhibits/fixtures and fittings to any persons or other objects. Vendor agrees to hold harmless Eons Expos RLLLP and all its employees and agents from any damages or fines imposed due to violation of any law or ordinance, which may occur anywhere within the Coliseum Show name or space. Vendor agrees to comply with all terms and conditions herein and protect, indemnify, save, or hold harmless Eons Expos RLLLP, and all agents and employees against any and all cost, damage, loss, liability or expenses arising from actions or by reason of said Vendor occupancy and use of assigned selling space through the Denver Coliseum Show as stated herein this agreement. Vendor will comply with all building and local government fire regulations, including but not limited to flame proofing regulations and electrical regulations and ordinances.
