EARLY & STANDARD PRICING:

- To take advantage of the discounted EARLY ORDER PRICING, orders must be received by August 15th, 2017
- Orders received after August 15th, 2017 will be subject to STANDARD ORDER PRICING
- ONSITE orders will be charged at a 25% increase of STANDARD ORDER PRICING

PAYMENT SCHEDULE:

- All charges must be paid prior to close of show.
- If you are sharing a booth, the party responsible for renting the booth from the association is the only exhibitor we invoice.

METHOD OF PAYMENT

- For your convenience, we accept cash, checks and money orders drawn on U.S. Banks in U.S. funds, VISA, Mastercard, Discover, and American Express.
- Purchase orders are not considered payment; therefore, a check or credit card is required.
- Exhibitors may mail or fax their order with payment to Dynamic Events of Denver.

CANCELLATION POLICY

- Orders cancelled prior to installation will be charged 60% of the original price. Orders cancelled after move-in begins will be charged 100% of original price.
- No adjustments will be made after the close of the show.

TAX EXEMPTION

- If tax exempt, a copy of your tax exempt certificate must accompany your order. This is not a resale certificate.
- No adjustments for tax exempt status will be made after the close of the show.
- To qualify for tax exemption in Colorado, most counties require both a city and state exemption certificate.

EXHIBITOR SAFETY

- Standing on chairs, tables or other rental furniture if prohibited. Dynamic Events will not be responsible for improper use of furniture.
